## Corvettes of the Bay “Community Connection”

Forty years ago, Wisconsin became the focal point of an uprising to stop a national public policy that restricted driving freedoms.

In 1982, the National Motorists Association, then the Citizens’ Coalition for Rational Traffic Laws, was formed in Dane County to oppose the 55-mph national maximum speed limit that had become the law of the land in 1974. The NMA’s constituency quickly expanded as drivers across the country embraced the mission to repeal the regulation designed to restrict traffic to speeds well below that for which our roads were designed.

It took several years and constant lobbying by the organization in Washington DC, but the people’s will ultimately prevailed. 55 mph became 65, 70, and then 80 in a few less-densely populated areas in Idaho, Montana, Nevada, Oklahoma, South Dakota, Texas, Utah, and Wyoming. A west Texas state highway has the current distinction of being the USA’s only road posted at 85 mph!

With that generational success of forcing the repeal of the 55 mph national limit, the NMA continued to grow as a drivers’ advocacy organization. We have assumed a leadership role for many motorist issues, from fighting against unreasonable road user fees to opposing automated enforcement and intrusive government surveillance on our roads.

Today, the NMA is a 501(c)(3) nonprofit organization with 8,000 active members in all 50 states and Washington DC. Driver-related research and educational projects are a significant part of our activities, but being a vocal advocate for the nation’s 250 million licensed drivers is a core principle. NMA members, like those of Corvettes of the Bay, are auto enthusiasts who cherish the pleasure of getting behind the steering wheel of incredible driving machines.

Never has that been as important as today, with the current strategy announced by the U.S. Department of Transportation to again enact lower speed limits while ratcheting up enforcement with speed cameras. We have been fortunate that Wisconsin is one of several states that disallows the use of automated ticketing devices on constitutional and due process grounds. That may change as the federal government dangles funding in front of states as an enticement to cooperate with their plan, unless we all become drivers’ rights advocates.
