### CORVETTES OF THE BAY BOARD OF DIRECTORS and LEADERSHIP ROLES EXPECTATIONS AND ASSIGNMENTS

#### **Expectations of Board of Directors**

- 1. Attend quarterly board meetings in December, March, June, and September.
- 2. Actively participate in discussions at meetings and offer suggestions for agendas for the next meeting.
- 3. Respond in a timely manner to questions or requests from other board members and club members.
- 4. Proactively consider and communicate ideas to improve the club and its administration.
- 5. Provide input at annual budget discussion in September.

#### **Assignments - Officers and Board Members**

#### **President - Officer position**

Prepare and print the meeting agenda and preside at all member meetings and board meetings. Email a copy of the agenda to the secretary before the meeting.

Draft a letter to members for each monthly newsletter.

Review minutes for the secretary before they are added to the newsletter.

Serve as a member on all club committees (this is stated in bylaws, but is it practical/necessary?) President and treasurer ensure completion of annual required filing to maintain 501(c)(7) tax exempt (online form). Godfrey and Kahn will complete the filing for nonprofit status for Federal and State of Wisconsin.

Keep a copy of the club insurance policy and serve as the point person for COB registered Representative Godfrey and Kahn in filing the Wisconsin Nonstock Corporation annual report. Maintain custody of all corporate property.

Serve as past president on the board the following year.

#### **Vice-President - Officer Position**

Serve as president-elect, becoming president in the next year. Preside at membership meetings when the president is not available. Collaborate with president on agendas. Take notes on agenda topics or discussions that need follow-up.

#### **Past President**

Assist the officers and board members by providing continuity, advice and help with special projects. Take the lead in working with the organizers of special events.

#### **Secretary - Officer Position**

Keep minutes of all board meetings and membership meetings.

Send electronic copy of minutes of membership meetings to president for review, then submit to newsletter editor for printing. Keep a copy of articles of incorporation, by-laws and membership roster and other documents for the archives. Have available for reference by members on request.

#### **Treasurer - Officer Position**

Pick up mail on a regular basis from the Corvette Post Office box and process or distribute.

Sign checks and pay bills.

Provide a verbal financial report at monthly membership meetings.

Administer the sunshine fund: send a check to the Corvette member family at time of death according to the following directive: \$50 for spouse or child, \$25 for father, mother, or sibling.

Prepare a budget for board review at the September board meeting. Show current year income and expenses and projected end of year balance. Suggest budget amounts for the upcoming year.

Prepare a final copy of the approved budget and review with the board of directors and members at the respective annual meetings in December.

President and treasurer ensure completion of annual required filing to maintain 501(c)(7) tax exempt (online form). Godfrey and Kahn will complete the filing for nonprofit status for Federal and State of Wisconsin.

Maintain financial records of the club and keep copies of receipts and records for 7 years.

Update the "board" tab on the website when board membership changes.

#### At large board member duties are assigned each year.

- 1. Collaborate with the people responsible for Facebook, Website, and newsletter to implement changes when needed. (i.e., after the board has agreed to changes to the website, work with the webmaster to agree on cost and explain the changes requested.)
- 2. Print labels for newsletter, pick up printed newsletters from printer, affix end sticker/seals and labels. Drop off at Gandrud or Broadway in alternate months to mail.
- **3.** Manage distribution of new member folders: buy folders, update contents, and give to new members. Take individual photos of new members at monthly meetings and forward the photos to the webmaster.

**Motion to Approve August Meeting Minutes:** President Tony called for a motion to approve the August minutes as posted in the newsletter. Motion was made by Dan Brunmeier; motion carried.
